SUBJECT: EXPULSION ORDER

1. An investigation was conducted to confirm or deny the charges against "NF HADJI" Delgado at Ipil, Sibugay Province and Dipolog City respectively.
2. "NF HADJI " Delgado is one of the original incorporators of the faction Guardians Brotherhood Federal inc. formed by expelled National Founder Dionisio "DANIEL" Quieta , Sr. and registered at Davao City.
3. "NF HADJI " Delgado promoted several Founders to the rank of National Founders at Dipolog City for monetary consideration of One Thousand Pesos (PhP1,000.00) and Five Hundred Pesos (PhP 500) for those promoted from RMG to Founder without receipts and without the knowledge and consent of the National Triumvirate and the National Promotion Board.
4. Effective December 15, 2008, "NF HADJI" Delgado is expelled from the Guardians Brotherhood Incorporated –Mainstream, The FIRST, The ORIGINAL.
5. So ordered.

SUBJECT: SUMMARY OF INFORMATION

RE: CASE AGAINST CPO ALFREDO “NF HADJI” DELGADO, JR. PN

i. FACTS OF THE CASE:

A complaint was filed by Macacna “NF MAC” A. Urabang, Regional Founder – IX before the nNational Justice Tribunal through the undersigned Commissioner, Rogelio “NF AUGUST” Cena.

NF HADJI Delgado was made and required to answer in writing all the allegations and charges against him by the incumbent Regional Founder “NF MAC Urabang, per communication sent by “NF AUGUST”.

NF HADJI Delgado submitted his duly sworn answer to the above cited Commissioner Rogelio “NF AUGUST” Cena of the National Justice Tribunal. However, all the occasions as contained in the complaint of NF MAC Urabang were denied by “NF HADJI” Delgado.

Dante "NF OFFROAD" Simangan, the Finance Minister confirmed that indeed the Guardians Brotherhood Federal Incorporated was registered with the Securities and Exchange Commission at Davao City and that "NF HADJI" Delgado is one of the original incorporators of the said GBFI of expelled Dionisio "XNF DANIEL" Quieta, Sr.

In depth investigation was also conducted at Dipolog City whereby it was gathered that "NF HADJI" Delgado promoted GBI Members of Dipolog City to the rank of National Founders without the knowledge of the National Triumvirate bypassing the Provincial Founder of Zamboanga del Norte "NF PAT" Alipuyo. Assessment for said promotion from Founder to National Founder was pegged at One Thousand Pesos (PhP1,000.00) while from RMG to Founder at Five Hundred Pesos (PhP500) each all without receipts.

At Ipil, Sibugay Province, he also tried to convince GBI Members to join their group under "XNF DANIEL" but did not succeed.

This is a manifestation of grave abuse of discretion; usurpation of authority which is contrary to the provisions of the GBI – Mainstream Constitution and By-Laws, a very serious offense.

ii. **RECOMMENDATION:**

The Investigating Panel therefore is recommending the immediate expulsion of CPO Alfredo "NF HADJI" Delgado Jr. PN (Active Phil Navy) from the Guardians Brotherhood Inc. – Mainstream, The FIRST, The ORIGINAL without prejudice to filing of criminal charges in the Court of Law.
