RESOLUTION No. 000-002-2009

“Resolution creating the International Relations Division that will be in-charge of recognizing and establishing communications and other official actions with members of the Guardians Brotherhood Incorporated (GBI) and other Guardians belonging to other group or factions who wishes to re-activate or reconcile with the GBI- Mainstream.”

WHEREAS, The Guardians Brotherhood Incorporated (GBI- Mainstream), established in December 10, 1984 with SEC Registration No. 123899 has expanded its membership not only in the Philippines but including other parts of the world, recruiting Filipinos and foreigner as well that are qualified under the new Constitution and By-Laws;

WHEREAS, There are also other members of the Guardians who belong to other groups of factions who at the time of their membership were not fully aware of the classification of factions and that they now realized that the GBI- Mainstream is the original and the truly and legitimate Guardians since it was established in 1984;

WHEREAS, These individual members and or chapters are currently establishing communication with members of the GBI- Mainstream and expressed their desire to officially affiliate with the Guardians Brotherhood Incorporated (GBI- Mainstream) and be recognized;

WHEREAS, In order to fully implement the requirements of officially entry and affiliation and the determination of those who shall qualify to be accepted either by affiliation or recognition, a legitimate and or legal body within the GBI- Mainstream shall be created to handle cases such as those mentioned above;

WHEREAS, The body to be created shall be the only body to be communicated by these overseas members and shall have the authority to officially respond and act legally on whatever request or situations there shall be for any situation that may occur;

NOW THEREFORE, IT IS RESOLVED, AS IT IS HEREBY RESOLVED, that the INTERNATIONAL RELATIONS DIVISION (IRD) shall be created which shall be under the office of the Guardians National Triumvirate (GNT) and shall be headed by an International Relations Director appointed by the Supreme Master Founder (SMF) with the following duties and functions:

1. To take exclusive charge of all international transactions of the GBI- Mainstream including overseas members and other overseas transactions which shall be permitted by the Supreme Master Founder (SMF)
2. To recommend to proper authorized bodies all request and or other official actions to and from these overseas members and or chapters for actions
3. To monitor all activities of these overseas members and or chapters and submit reports to the proper authorized bodies of the GBI-Mainstream for information\
4. To require the submission of reports and other important documents, and authorized fees and dues including donations and contributions as authorized by the Prime Minister and the Finance Minister, with prior approval of the Supreme Master Founder (SMF), and submit and or remit the same to the proper authorized officers of the GBI- Mainstream

RESOLVED FUTHER, that International Relations Division (IRD) shall be composed of the following:

1. Supreme Master Founder or Master Founder as authorized by SMF
2. International Relations Director (with the rank of NF)
3. 3 members, one each for Mindanao, Visayas & Luzon (with the rank of NF)
